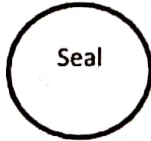

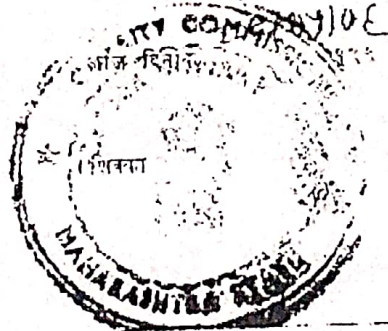

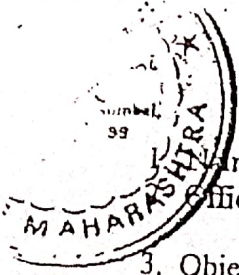

3. Objects of the society: For Educational, Medical and Charitable Purposes.

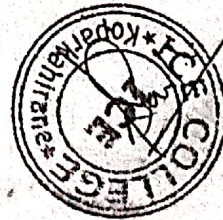
A. EDUCATIONAL OBJECTS: The educational society main object is education for all,

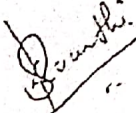
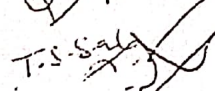
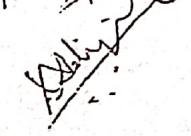

RULES AND REGULATIONS
HOPE FOUNDATION

1. Definition of terms used in Bye- Laws:

- a. Accounting year:- Means by 1st April to 31st March as financial Years
- b. General body:- includes all ordinary members as well as life members.
- c. Society:- Means hope foundation
- d. Rules :- Mean Rules prepared and established by the General Body meeting.
- e. Management:- Means the committee of the society,

2. Area of Operation:-

The area of operation of Foundation shall be through out Maharashtra.

3. Accounting year:-

Accounting year of the foundation shall be 1st April to 31st March

4. Membership and procedure for enrollment:-

Any adult male or female residing in Maharashtra and who agrees with the terms and objects of the foundation and who agrees to abide the rules and regulation of the foundation can be a member of the foundation.

The person should apply in prescribed form prepared by the committee and should pay the prescribed amount as fee of the foundation. He should submit his application to the secretary or any legible office bearer and in the general meeting of the members the application will be put to vote and on the bases of the decision of the members in the meeting the application may be accepted or rejected.

5. Kinds of Members:-

- a. Ordinary Member: - A person who pay Rs 100 annually with a entrance fees of Rs 50 annually will be called as ordinary member
- b. Life member: - Who pay Rs 2,500 a lump sum amount will be called as a life member. However, at present at time of registration all members of the committee. have an ordinary member.

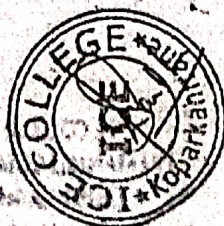

6. Termination of membership.

A person shall ipso- facto cease to be a member.

- a. On his death
- b. On his resignation of membership.
- c. If he convicted of criminal offence involving moral turpitude.
- d. If he fails to pay his subscription and / or membership fees for more than a year etc.
- e. If the Society with 51% or above majority pass a resolution to terminate the membership of a particular member in a meeting.

7. General Body Meeting its Power and Junctions.

The General body meeting of the society shall be held once in a year within 90 days immediately after 31st march of every year at such place, time and date as managing committee shall determine.

Business of the Annual General Body Meeting :

- a. To confirm the minutes of the previous Annual General Meeting.
- b. To adopt the previous year and audited statement of accounts.
- c. To admit new members as per decision taken by Managing Committee.
- d. To appoint Advocate/ Legal advisor, Chartered Accountant and fix their remuneration.
- e. To consider any other matter, due notices of which has been given five days prior to the General Body Meeting.

8. Notice of General Body meeting and Quorum

The President/ General Secretary shall convene the General Body Meeting. The meeting and its Agenda shall have been announced in the previous General body and / or Managing Committee. A list of members eligible to participate and vote in the General Body Meeting shall be published in display at the office of the foundation before 21 days of the General Body and notice to the members is given 14 days before the date of A.G.M. In writing by the Secretary / President. 2/3, shall be quorum of the General Body meeting. Minimum one General Body meetings shall be held in a financial year.

Any adjourned meeting for want of quorum shall be held half and hour later at the same place and the members present in this meeting shall form quorum, but no business other than specified in the notice of the said GB shall transited at such meeting.

9. Extra ordinary General Body Meeting and its functions

An Extra-Ordinary General Body Meeting may be convey by the managing committee of its own motion, or upon a requisition made in writing by chairman and / or any five members, of the society. Such requisition shall specify the subject of the meeting proposed to be called and must be signed by all five requisitions and shall be delivered at the office of the society. On receipt of the requisition the Managing Committee shall forthwith proceed to convene an extra-ordinary meeting. If managing committee fails to do so, then the chairman himself or requisitionists requisition. The quorum for the extra General Body shall be $2/3^{rd}$ of the total members of the society on record.

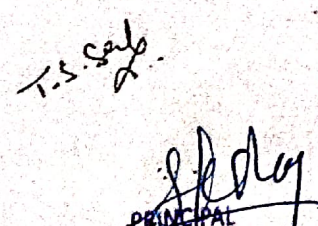
10. Managing Committee / Office bearers :-

The management and administration of the foundation shall be carried out and managed by the managing committee. The managing committee shall constituted as following :-

11. Term of the Managing Committee and procedure of election of the office bearers.

Term of the managing committee shall be term three years after the expiry of three years within two months the General body of the foundation shall be held i.e. 60 days the election as per the rules specified and elect the managing committee as above. The Managing committee will select the office bearers in their first meeting held amongst themselves within 30 days period. Any retiring member of the managing committee shall be eligible for election the casual vacancies however, may be filled up by the person elected on the casual post shall hold office for the remaining period.

12. Office bearers of the managing committee and their duties:-

a. President

The President of the Society shall preside over the meeting and regulate the meeting of the managing committee. The president shall in addition to his rights of voting as a member has a casting vote in case tie.

b. Vice President:-

The Vice-Chair person shall occupy the chair of the Chairman in his absence.

c. Secretary:-

The Secretary shall accept application for membership and submit to the managing committee and he will maintain membership register upto date. He shall maintain minute book and attend daily routine correspondence. The Secretary shall maintain all other necessary books.

d. Joint Secretary :-

In the absence of secretary the joint secretary holds the office and help day today management and foundation.

e. Treasurer:-

The treasurer shall ordinarily receive all payments made to the society and pass the necessary receipts and shall maintain account books.

e. Joint Treasurer :-

In the absence of secretary the joint secretary holds the office and help day today management and foundation.

13. Meeting of the managing committee and requisition meeting :

The requisition meeting of the Managing Committee may be convey upon a requisition made in writing by the president, and / or any three members of the Managing Committee members. Such requisition shall specify the subject of the meeting.

On receipt of the requisition the managing committee shall forthwith proceed to convene the meeting. If, Managing committee fails to do so, then the President and / or the requisitionistes themselves may convene such meeting within 10 days from the delivery of such requisition. Quorum for the requisition meeting shall be 2/3rd members present in the meeting of the managing committee.

14 Notice of Meeting of managing Committee and quorum :-

2/3 rd members present in the meeting shall form a quorum of the managing committee. If meeting is adjourned for want of quorum shall be held on hour later at the same place and members present shall form the quorum. But on event any business that is specified in the Notice be transacted in such meeting.

15 Rules of election of management committee:-

The management committee shall be elected as per the secret ball at system if necessary otherwise as per open election procedure i.e. show of hand in the GB called for that purpose: - election should be held at such place, time and date as the Management Committee decide the officer other than members of the foundation to control over the election and to declare the elected member at the time of election etc.

16. Filing of Vacancies in Management Committee

Any Vacancy caused due to death, resignation or any other circumstances the Management Committee shall have power to fill the vacancy for remaining period.

17. Power and duties of management committee :-

The Management Committee shall work and have full powers and authority to do all acts, matters, things and deeds which may be necessary or expedient for the purpose of and in particular to the following: -

- i. To control the society and its properties
- ii. To admit or reject new member and accept resignation of the members.
- iii. To have an audited statement of accounts prepared every year for submission to the registrar of societies and any other authority as may be required by the law for the time being in force, if any.
- iv. To accept donation in cash or in kind on such condition and without conditions.
- v. To make an appeal to the people for general donations as per the decision of the General Body.
- vi. To appoint such committee with such powers as the management committee may think fit and proper for such purpose, And /or to dismiss the same when the purpose is full- filled.
- vii. Generally to do all such other acts, things, as are incidental or conducive to the attainment of the above powers and duties or any one or more of them and aims and objects specified in the Memorandum of Association/ Society.

 2. Maintenance of the office and properties and institution of the Foundation and other buildings.
 3. Salaries of the Employees, if any of the foundation.
 4. Advertisement expenses
 5. Expenses on account of Schools, Charitable Hospitals, Orphanages, Schools, Spiritual Groups, and Missionary activities and for the objects mentioned in the memorandum.
- Education: 80%, Medical 5 %, and other 15 %.

20. Provision for loans and deposits:-

The managing committee shall have power to borrow money or take Loan (whether by way of mortgagee, pledge, and hypothecation Or otherwise) for the purpose of or on behalf the society only with the Previous sanction of the Registrar of societies and / or any other Authority As required by the law, Subject to such conditions and limitations as may Be imposed by the Registrar or competent authority.

21. Provision regarding purchase and sale of immovable property:-
 The Society can buy and sell immovable property, Management committee should determine for purchase and sale price of such immovable property.

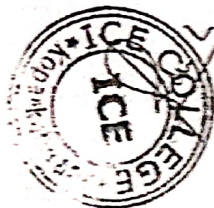
24. Provision for change/ amendment in the Rules and Regulation :-

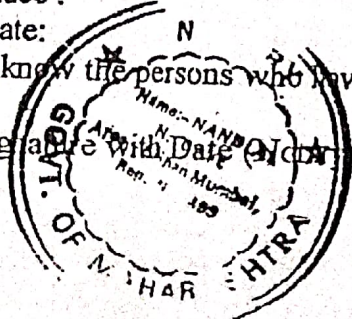

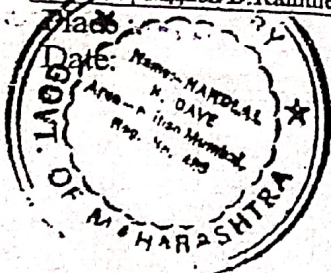
